Dear Mr. Abouna:

As you know as of April 11th the SanGIS Board of Directors approved a recommendation to "create a management committee that manages the operational decisions of SanGIS and limit Board involvement to high level decisions". This action item was approved by the SanGIS Board subject to the verification and approval of SanGIS counsel. On April 23rd and April 28th SanGIS Counsel verified the action was legal.

This committee will be comprised of a representative from the City of San Diego and the GIS Manager from the County of San Diego. It shall be created and referred to as the "Management Committee". With its delegated authority, the Management Committee will answer to the Board as described in the SanGIS JPA under Section IV (b). This committee will be delegated the authorities of the Board as described in the SanGIS JPA under Section IV (e). "Responsibilities of the Board." The limited exceptions to these delegated authorities are:

- 1. The Management Committee shall not approve the annual budget.
- 2. The Management Committee shall not approve the expenditure of SanGIS funds not in substantial conformance with the annual budget and not in excess of \$50,000 in any one action or more than \$150,000 in any one fiscal year.
- 3. The Management Committee shall not issue bonds.
- 4. The Management Committee shall not hire private legal counsel and certified public accountants.

The full responsibilities of the Board of Directors are described in the SanGIS JPA. With the above mentioned exceptions, these rights are now delegated to the Management Committee. Any provision, right, or authority previously possessed by the SanGIS Board of Directors and delegated to officers or employees of SanGIS is hereby retained by the Management Committee with its creation.
