MEETING MINUTES

Review of Minutes from Previous Meeting(s)

Minutes from the Board of Directors meeting of May 18, 2017 were reviewed. A motion was made and seconded to accept the minutes as presented. The motion was passed and the minutes were unanimously approved.

Public Comment

No public comments were received.

Information and Discussion:

1. Current Financial Status

Mr. Lind presented the fiscal year-to-date budget-to-actuals report for the period July 1, 2017 through

August 31, 2017. Mr. Lind explained that based on the current report SanGIS projects a surplus of revenues over expenditures of approximately \$69,700 at the end of the fiscal year. Mr. Lind explained that the predicted surplus is due to lower than budgeted personnel costs primarily as a result of retirement.

2. SanGIS Succession and Transition Plan

The Management Committee presented a draft Succession and Transition Planning document and requested advice and direction from the Board on the final version. The Board discussed the draft and advised the Management Committee that it considers the document an operational plan and that approval by the Board is not required. However, the Board advised that SANDAG's contribution to the Management Committee be taken into consideration when finalizing the document.

3. Program Manager Transition

The Management Committee presented an update on the status of filling the Program Management position once the current contract expires in July 2018. The Management Committee presented various methods that could be used to fill the position and requested the Board's advice and direction on proceeding. The Board discussed the options and requested clarifications on the different methods. The Board requested that the Management Committee prepare a report on the expected budget impacts for different alternatives for review and discussion at the next Board meeting.

4. NextGen 911 Project Planning

The Management Committee reported that SanGIS staff have been developing plans to improve address point and road layers to meet the requirements for NextGen 911 system implementations and NENA standards. The Management Committee outlined SanGIS NextGen 911 plans, coordination with member agencies, funding sources, and budget impacts.

5. Best of California Award

SanGIS, the City of San Diego, and the County of San Diego were nominated for and won an award for Best IT Collaboration among Organizations by the Center for Digital Government. The Board was notified of the award. Board members congratulated SanGIS staff and management, including the Management Committee, and their efforts.

6. Other Items

Mr. Behnke requested a status update on the 2017 regional aerial imagery collection project. Mr. Lind reported that all partners except one have provided a purchase order or payment for the funding. The final purchase order issue is expected to be resolved in January.

The Board agreed that the meeting scheduled for November 16, 2017 should be set to start at 3:30 pm due to other schedule conflicts.

Mr. Sutherland described changes in progress at SANDAG and, as a result, notified the Board that a new Management Committee member may be appointed before the next Board meeting. The Board thanked Mr. Sutherland for the notice and for his many years of service to SanGIS.

Mr. Lind reported that the semi-annual usage report for the SANDAG/SanGIS Regional GIS Data Warehouse continues to show high utilization. For the 12 month period ending June 30, 2017 there was an average of one file downloaded every 6 minutes – 24 hours a day, 7 days a week.



Best of California Awards recognize new business and healthservices enablement tools, and other technology-enabled initiatives

Sacramento, Calif. – September 12, 2017 – The Center for Digital Government (CDG) presented the <u>Best of California Awards</u> today during the California Technology Forum. The Best of California Awards recognize state and local government organizations for innovative technology initiatives.

This year's Best of California awards include 18 winners.

Mayor Eric Garcetti's Innovation Team was honored with two winning initiatives, the Los Angeles Business Portal and the Los Angeles Indices of Neighborhood Change and Displacement Pressure. The Los Angeles Business Portal is a mobile-first, multilingual educational site that simplifies the process for entrepreneurs to launch or grow a business in Los Angeles. The portal is an excellent example of the digitization of government services – enabling responsiveness, efficiency and transparency in how government interacts with citizens. Previously, registering and starting a business could take weeks - it now takes as little as 20 minutes.

The Los Angeles Indices of Neighborhood Change and Displacement Pressure (LAINC) is an interactive mapping application and data analytics tool that provides insights into socioeconomic neighborhood changes and predicts vulnerability to residential displacement. LAINC helps ensure LA's programs are accurately targeted and deployed.

"The digital age has given local government new opportunities — and responsibility — to share data that delivers transparency and brings unique insight into where we live and how business is done," said L.A. Mayor Eric Garcetti. "L.A. is a digital leader because we believe in the power of information to help solve our greatest challenges, grow our economy and drive innovation in the public and private sectors."

The Best of California awards included two for Covered California, for their Enrollment Partner Portal supporting over 5,000 enrollment partners statewide, and for their social media campaign "Real Stories of Covered California," which features videos of members designed to help drive engagement and enrollment in the program.

The Department of Corrections and Rehabilitation (CDCR) also was recognized twice – for the Environmental Health and Safety Program, which establishes electronic medical recordkeeping for all 59,000 CDCR employees and for their Virtual Integrated Mobile Office, which eliminates

the need for field books and reduces travel time, resulting in staff time savings of 175,000 hours annually.

"I would like to extend my congratulations to all of the nominees and winners in this year's Center for Digital Government's Best of California Awards," said Amy Tong, chief information officer, California Department of Technology. "As a public servant, I know first-hand that much of the great work we do can often be overlooked. These awards are an excellent opportunity to highlight innovation in technology and how it can positively impact the lives of Californians."

Best of California Award winners are selected by a panel of judges based on several criteria, including collaboration among agencies, innovative use of technology, economic benefits and improving public services and business processes.
